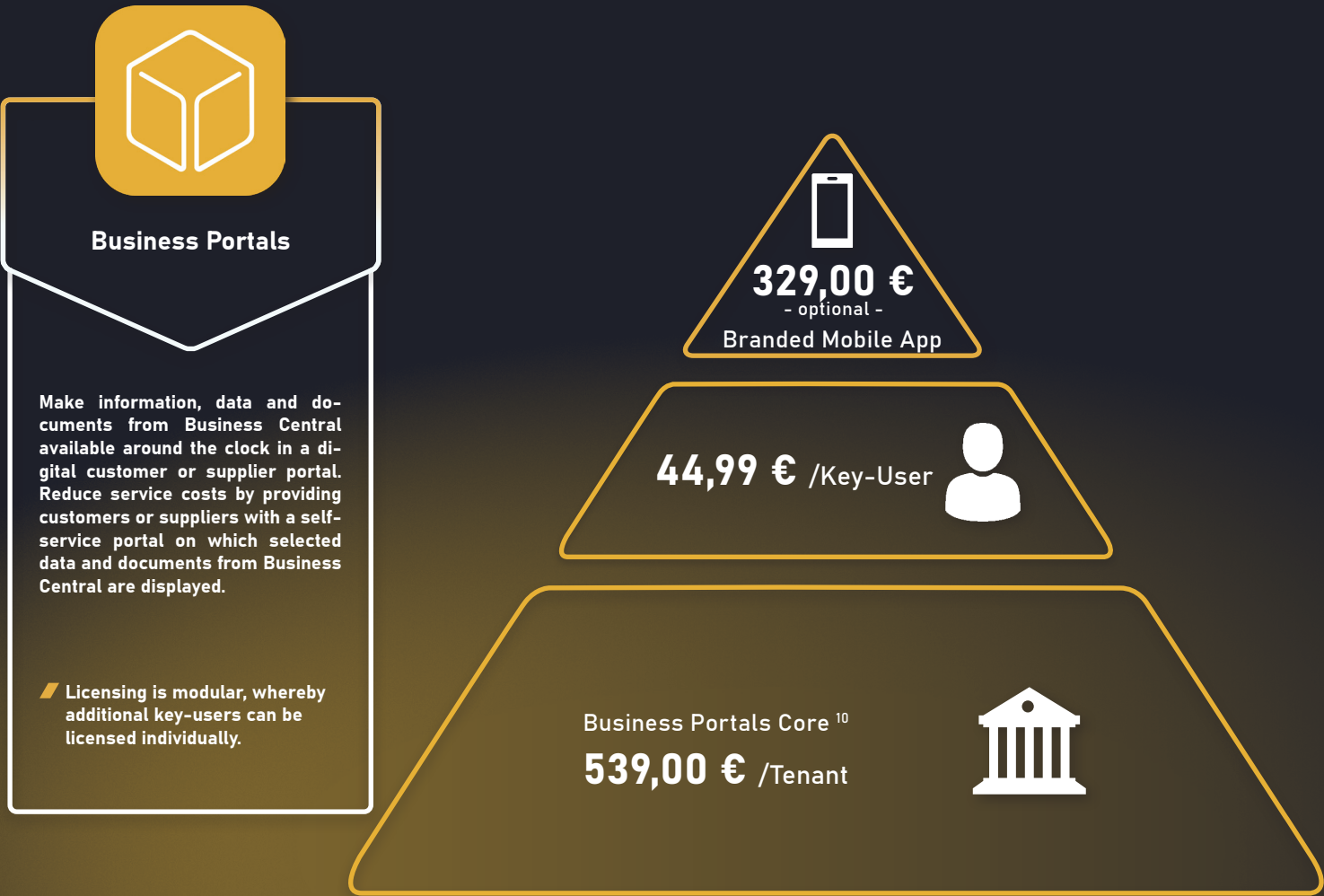

The number of transactions is tracked by Simova API. Transactions originating from different products and environments are aggregated to determine the progressive price per transaction. At the same time, they remain segmented by activation key to ensure full traceability. This makes it possible to identify whether individual transactions were generated in a production environment or in a test environment. Simova API only tracks the number of transactions and is not in conflict with privacy laws regarding sensitive information.

### What is transaction-based progressive pricing?

Our pricing model for Document Inbound and the B2Brouter Integration for Document Dispatch is based on the number of transactions processed per month. We offer a progressive pricing structure, meaning that the cost per transaction decreases as your monthly transaction volume increases. Each month, the actual transaction price is calculated dynamically using a sophisticated formula, ensuring that you always receive the most favorable rate for your usage.

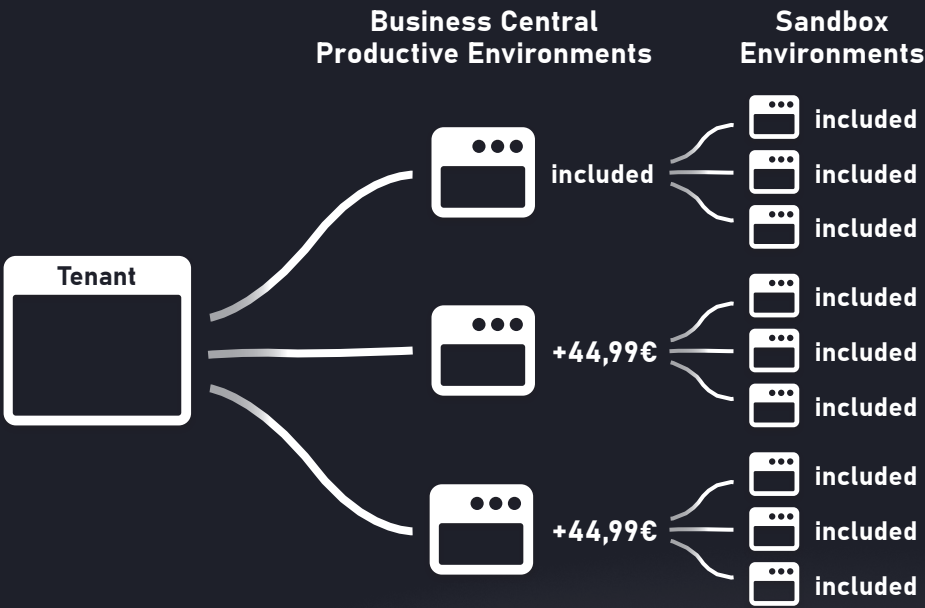
Depending on the transaction volume, the price per transaction ranges from approximately €0.15 to €0.0005. The more transactions you have, the lower your price per transaction.

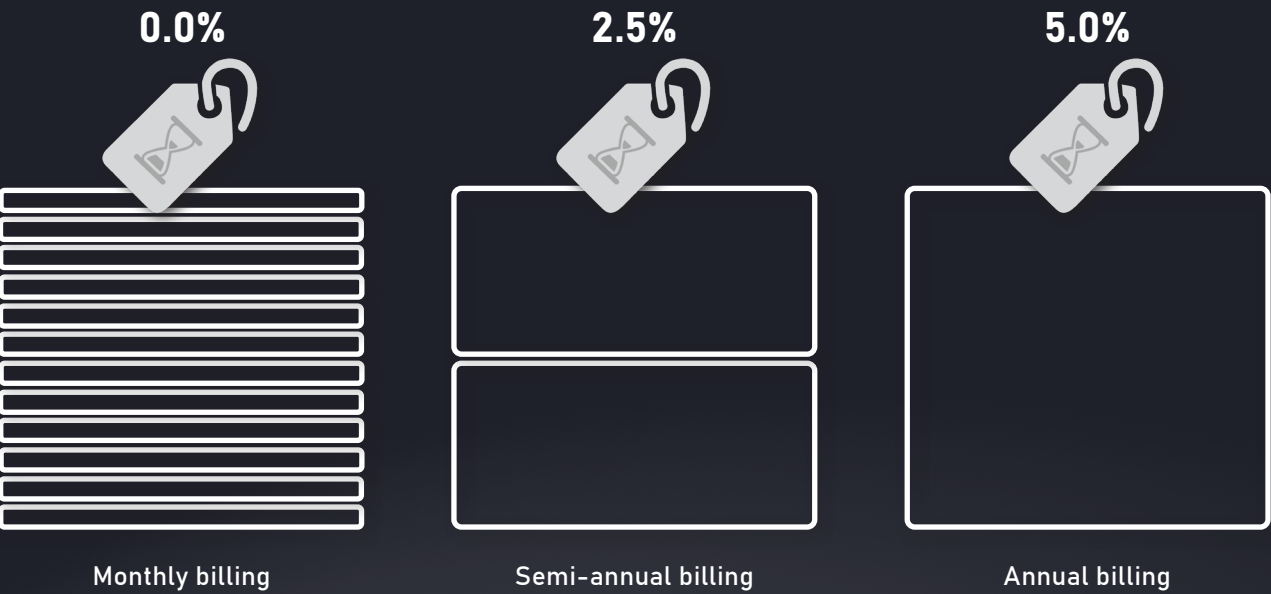
